**PDG Keith Williams, Chair (22A)** – Yesterday the committee presented the Mid-Winter Conference in which we covered many items such as schedule, hotels, entertainment, duties of the Governors, Vice District Governors, cabinet secretaries and treasurers and much more.

In the past several weeks the convention committee has been hard at work providing you all with the finest convention possible. Some of the things we have accomplished are: the hotel mailing has gone out to the Governors for their distribution, signing of the entertainment contract, arrangements for a night at the Shorebirds ball game, scheduling of all events at our convention, shuttle bus service between the civic center and the hotels - more on this when it is finalized. We need input from the Governors on committee assignments and the theme for this year's Convention.

Lion Charlene Travers (22B) – I have been working on the exhibit booths and contacting those that were there last year; if you know of any exhibitors personally or in your area, or craft exhibitors, please e-mail the information to me and I will be glad to contact them. Golf tournament will be on Thursday morning of May 12 at Nutters Crossing Golf Course. We have worked out the particulars with the golf course as far as lunch and registration. We need to promote the golf tournament any way we can; please do whatever you can in your district such as including the information in your newsletters.

**PDG Keith Williams (22A)** – In your package is a statement of the current income and expenses showing the revised budget which we adopted last month which was approved by the Council via e-mail. We are late getting out the ticket order form. We have some expenses coming up shortly, especially the balance due to Wicomico County in the amount of \$9,600.00. We may get enough ticket money in, in order to make the payment. I ask the Council to consider advancing to us, at this time, the \$10,000 pledged to go towards transportation, or \$5,000, or the balance of multiple district convention dues; if you consider this, we will be able to make our payment to the convention center on time. In addition, the Council of Governors should select a theme for this year's convention.

**DG Bill Bicknell (22B)** – I suggest we adopt the theme *Making a Difference* which would include five parts which coincide with the International President's theme: youth, sight, hunger, wellness and the environment. The marketing of the theme be buttons and banners with the acronym MAD for Making a Difference. I am seeking involvement, if we adopt this theme, of the Purdue organization in Salisbury, hoping that they will adopt this as a company motivational area, as they are involved in all five of these activities. I've had some preliminary discussions with them and invite them to be a partner internationally and to support these five endeavors. Our theme should be *Making a Difference* with the acronym MAD and our seminars and exhibits should emphasize these five items.

**CC Ralph Schieferstein (22D)** – Sounds like a great idea; do we have time to accomplish this in three months? It sounds like a great Multiple District Project.

**DG John Cullison** (22A) – I like the concept of *Making a Difference*; I'm not sure about the MAD acronym; I don't think I could go with that. If we don't go with the International President's theme, *Beacon of Hope*, I would recommend that we go with the theme, *Making a Difference*.

**DG Bill Bicknell (22B)** – The International President's theme uses the Cape Hatteras lighthouse and the *Beacon of Hope* as his theme. I have no problem going either way for the convention; I am merely suggesting something that would give us motivation and a purpose for our convention.

**DG Bill Bicknell (22B)** – Moved to adopt the *Beacon of Hope* as the theme for this year's convention; second by DG John Cullison (22A); motion carried.

**PDG Keith Williams (22A)** – I received only two of the five requested lists of committee assignments for the convention; I am going to bug you every time I see you for those lists. Our IP Sid Scruggs will be with us at the convention the entire time.

**PIP Clem Kusiak** (22A) – I have firmed up IP Sid Scruggs' schedule for the entire convention. In the past, we have had time for our President to visit one of our signature programs such as LVRF. He loves to play golf. He is open to our program and has committed to be here for the entire convention.

**PID Darley Travers (22B)** – For those who are not aware, in Salisbury at the Civic Center, you can take in all the alcohol that you want but you cannot sell it. The property on which the Civic Center sits was given to the county and this restriction is in the deed. For the hospitality night, it is up to each of the Governors to do what they want to do. For anyone wanting to serve alcohol, the Civic Center will provide a supervisor bar tender to co-mingle with the others. Yesterday, the Council made a motion which was seconded and approved, that everything will be BYOB except for the VIP meeting.

CC Ralph Schieferstein (22D) – Yesterday when we discussed this, we said that the Past District Governors' banquet and the Multiple District banquet would be BYOB. The VIP meeting will be furnished by the convention committee. The personal hospitality rooms should not be an issue. The group hospitality room after the Shorebirds game will be up to the candidates and what they want to provide.

**PIP Clem Kusiak** (22A) – When out in the public, be discreet about bringing alcohol; do we want to give the wrong impression?

**PDG Keith Williams** (22A) – The hospitality areas will be in the arena; I need to know how much space the candidates need.

**PID Joe Gaffigan (22C)** – If the convention were coming to my area, my club of 25 would find a way to fund any alcoholic beverages; I suggest that you get local clubs to sponsor any alcohol.

**DG Bill Bicknell (22B)** – There are frequent events at the civic center in which attendees bring their own bottle. We are particularly fortunate to have PID Darley here who was the chairman of the Wicomico Liquor Board for many years. I believe that because of Darley's relationship with the civic center and with the people in charge, we are being granted additional latitude; we should not abuse that latitude. I share Joe's concern about our flaunting it; our members need to stay in control. If the committee would feed back to us any concerns about particular venues during the convention, I think we can work with this. I will be glad to solicit volunteering clubs to sponsor any alcohol.

**PDG Keith Williams (22A)** – Complementary bartenders will be provided by the civic center.

**PDG Keith Williams (22A)** – We need possible convention sites for 2016.

**PDG Rodney Welch (22W)** – reported on the Eisenhower Center in Gettysburg. PDG Tom Jefts and I went back to talk to them about the social for next year and for the MD convention. They have 308 rooms in-house, two ballrooms, both available, and all meeting space we could ever want. Sub-district luncheons can be held with separate space and separate food. When you leave there and go into Gettysburg there are multiple chain hotels and restaurants. It looks dated in the old part; in the new part it looks fine. There is the possibility that the entire facility would be renovated prior to our use by two businessmen who hope to purchase the property and establish a casino. However, the town and others do not want a casino in this historic area. Today, I will deliver a bid package developed by PIP Clem, IPDG John Atkins and the Council, to them.

**PDG Tom Jefts (22W)** – I now live in Hagerstown and am involved in planning the 22W social. I moved the 22W social back to Hagerstown which will be a showcase by the county commissioners. At the present time there are 6-8 new hotels, there is an airport, and there are two hotels within a mile of each other that are capable of being the headquarters hotel. Comps are one for every 25 registrations. It is convenient to two interstates; there is a transit system available there which can be flexible; there is all kinds of shopping and dining in the area. Washington County, Hagerstown specifically, would like to be considered for 2015 and 2016.

**PID Joe Gaffigan (22C)** – any bid or any site we look at 30-45 days the new council... Response must come back by the mid-winter conference for evaluation of the bids. It is late for this year; the first vice presidents can consider Hagerstown and the other sites in the process.

**CC Ralph Schieferstein (22D)** – we may be last minute making approvals for 2016 because of delays in getting the bid packages out. National Harbor, a cruise out of Baltimore and Gettysburg are the locations being considered.

**Bill Bicknell (22B)** – it strikes me that the bottom line is having a good convention that is attractive to Lions to attend. It will be a lesser issue if we can accomplish a more outstanding convention.

**Bill Bicknell (22B)** – moved that we entertain a proposal from Hagerstown for 2016; second by John Cullison (22A); after comments and discussion, District Governors Bill and John withdrew the motion.

CC Ralph Schieferstein (22D) – the bid packages have not been put in place; we are waiting for the bid package to be presented to the Council for approval.

**Don Beeson** – I sent some information out through Lion Susan; did you all get that? Hotel rates in DC are due to go up next year; no matter where we wind up we are going to be looking at higher rates than we are used to. As Chairman Keith mentioned, we were asked to look into 3 sites – cruise ship, national Harbor and Gettysburg. I looked at the internet for cruise ship information. To give her some background on our needs, we had at that time, a tentative

schedule for Salisbury including banquets, meeting space, etc.; I sent that to her. There was discussion of a small ship with just Lions; it is possible to charter an entire small ship; it would not necessarily have enough meeting space and the cost to do that would be \$2 million. Her recommendation would be to take a cruise on a ship that would have a large enough space for meetings. Her recommendation included a 5 day cruise from the east coast to Bermuda and back. Sites close enough to drive to include Baltimore and Bayonne, New Jersey (east of the Newark airport). One example was Explorer of the Seas operated by Royal Caribbean International, including 5 nights; all these quotes are based on 2015; leaving from Cape Liberty, New Jersey. Her prices were based on booking in 2015: junior suite - \$1775; deluxe balcony stateroom - \$1425; ocean view stateroom - \$1275; inside stateroom - \$910; all meals included. If contracted early on, rates might be negotiated lower than that. Cruise companies do not lay out itineraries five years in advance. The cruise she mentioned is very popular and usually sells out. That's where we are with the cruise situation.

The other option I was asked to look at was National Harbor, a large-scale development on the bank of the Potomac River at the Gaylord National Resort and Convention Center. They operate the Opryland Hotel in Nashville. It is a stunning place. Their facilities could have a half dozen conventions going on at the same time. Pricing is appropriate to a location in the metropolitan Washington area. They are very anxious to get the Lions in there. They gave me a very nice tour there. Based upon the same information as given to the cruise ship folks. The building is constructed like a huge "H" with the hotel side opposite the convention side. We could have everything on the hotel side and would not have to go into the convention side. There are 4-5 excellent restaurants in the hotel for your dining pleasure. They are willing to commit to room rates for 2015 in the \$199 range; there is possible room to negotiate this cost. They have a food and beverage minimum; she quoted \$200,000 for catered events. Meeting space would be complementary based upon 80% occupancy of rooms requested. For 2016, there would be a 5% increase. It is possible that this could be negotiated downward if they thought we were serious.

**PID Joe Gaffigan (22C)** – my suggestion is to put the key players on a short timeline in order to get the bid packages out to the three sites and back to you by a specific date. If necessary, call a special meeting to discuss the bids.

**PIP Clem Kusiak** (22A) – as an advisor to the Council. Should we restructure the convention committee? In December, I received a call from the chairman of the convention committee and I spent about 80 hours creating tools for them. The convention committee over a period of time builds on doing things that increases their activities. I have some recommendations at the end of the meeting. The convention committee has to be "glued at the hip" in supporting the Council of Governors in meeting your goals for your convention. This has to happen early. Over the years this has gone by the side and hasn't happened. Do you need to increase the size of the convention committee?

**DG Sandi Halterman (22C)** moved to advance \$10,000 to the convention committee; second by DG Bill Bicknell (22B); motion carried.

**DG Karl Gude (22D)** moved to have the bid packages back from the Multiple District Convention Committee for site selection by March 1, 2011; second by DG Richard Liebno (22W); motion carried.

 $1^{st}$  VDG Stephen Finger (22W) – I'd like clarification on which sites bid packages are being requested?

**DG John Cullison** (22A) – a cruise, National Harbor in DC and Gettysburg.

**DG Karl Gude (22D)** moved to require information updates on the 2015 Dover site from PDG Rodney Welch by February 15, 2011; second by DG John Cullison (22A); motion carried.

**PDG Keith Williams (22A)** – PDG Bob Jones (22D) has volunteered that his musical group to play at the hospitality room.

## **PDG Ken Watson (22-C), Constitution and By-Laws** No report.

**Lion Donna Jackman (22-W), Diabetes Chairperson** – (Note: This report was sent in writing, no verbal report was given at the meeting.) The Diabetes Chairman in each of the Districts of the Multiple District continue to work hard to create an awareness of the severe problems caused by this disease and strive to make the Lions and their respective communities aware of the complications caused by diabetes.

<u>District A</u> under the leadership of Allen Whitlock is making great strides to accomplish the goals of creating community awareness. He is working with hospital staff and establishing a diabetes support group in Bel Air and Abington areas. Their goal is to help diabetics have better management and control over their disease. On May 2, there will be a golf tournament to raise funds for Camp Possibility, which is a camp for children with diabetes. They are working toward having a Health Fair on September 24 which will host a 5K walk, run or bike event to raise funds. In addition, the Lions and medical staff of the hospital will conduct hearing, vision screening and test for diabetes. This District's Chairman is to be congratulated for his hard work and fabulous leadership.

<u>District B</u> continues to promote its diabetes program with Carlos Mir leading the way. He is continually presenting programs and has an advantage because his job involves him having access to all the latest information and supplies to keep his clubs informed. Carlos has a wealth of information and publications that he will share with anyone who desires more information.

<u>District C</u> has had programs presented by the District Chairman. Lion Rosann Seibel. She has presented programs to the clubs and is available and willing to speak to Lions Clubs or other community groups on diabetes. Rosann has a large collection of printed information to distribute and is willing to share it with all local groups to better educate the public and Lions on Diabetes.

<u>District D</u> with Lion Gary Stumpf as the chairman have had programs in some of the clubs and he has more presentations scheduled. He has not received any money for diabetes as of this date, but he is hopeful that funds will be coming in as spring approaches.

<u>District W</u> raised over \$15,000 toward finding a cure for diabetes. These funds were raised through their Frederick Walk and the Kiss-A-Pig Contest. All money was turned over to the American Diabetes Association and is ear marked 100% for research. The letters have gone out to the Health Departments in the five counties to promote sending any diabetic child, whose family cannot afford the cost, to Camp Merrick for one of the sessions this coming summer. The Jackman Memorial Fund, which was established to help with the expenses of sending diabetic children to Camp Merrick, has over \$2600 to date. District Chairman Donna Jackman has presented programs to clubs and has more scheduled for the spring. Our goal is to send at least 15 children to camp to help these children better understand their disease and how to more

effectively adjust their lifestyles to live a healthier and longer life and avoid the pitfalls that most diabetics encounter.

As most of you know, Dr. Arnall Patz, Emeritus Director of the Wilmer Eye Institute, passed away this last spring. When his colleagues and students asked how best to honor his memory, his family replied that whatever it was, it should include the Lions. He considered his involvement with the Lions and the forming of the Lions Vision Research Foundation one of the highlights of his career. Thus, the Arnall Patz Endowed Professorship at the Lions Vision Center had been formed. The cost of an endowed professorship is \$2.8 million, and is being raised by Wilmer Development. The Foundation has voted to assist this effort with a donation of \$50,000. At the January meeting of the LVRF Board of Trustees, the board voted to initiate a "Patz for Patz" campaign in order to raise additional funds for this professorship. The idea is for clubs and districts to honor the memory of Dr. Patz by donating funds in addition to their normal contributions to LVRF. If supported by this council, materials, provided by the Wilmer Development Office, will be provided to each club within Multiple District 22, and through them to each Lion, in order to advance this project. Note that this is a project of the Wilmer Development Office, with the support of your Foundation.

LVRF has a new website, developed by Delaware.net and funded by our Lions Vision Education grant from LCIF. The address is lionsvision.org. It includes areas of information about LVRF, educational programs, how to join Lions, among others. Try it – you will like it. We are looking for additional content for the site. Contact points are CC Ralph Schieferstein, Web Coordinator, and Heather Mays, Web Administrator.

**DG Bill Bicknell (22B)** moved to endorse the "Patz for Patz" campaign; second by DG Karl Gude (22D); motion carried.

**PCC John A. Lawrence (22-B), Leadership Chair -** The Regional Lions Leadership Institute at Emmitsburg will be held on 18 – 20 February, 2011, with both the basic and advanced courses being offered. The cost this year is \$160.00. We have a beautiful venue at the Federal Training Center, a talented group of faculty and staff from throughout our Multiple District, and an educational and informative program supplied mostly from Lions Clubs International. It is not too late to get your Lions to attend.

As of Thursday, 3 February, we have 72 registrants with 46 for the Basic Institute and 26 for the Advanced Institute. We are hoping for several more with a postmark deadline of Monday, 7 February; I need their names by tomorrow morning. PID Dave Stouffer, AKA Santa Klaus, will be our keynote speaker on Saturday night. We look forward to a good time, good fellowship, and good learning.

The District Governor Candidate School will be held 18-19 March at the Holiday Inn, the 22B Social's headquarters hotel. LCI has asked us to include certain materials. We will start at 10 a.m. on Friday the 18<sup>th</sup> and finish by lunch time by the 19<sup>th</sup>. The 1<sup>st</sup> VDGs should attend as part of your DG training; 2<sup>nd</sup> VDGs are strongly encouraged to attend. We get funds from LCI to cover the cost of attendance by VDGs. Anyone thinking of running for 2<sup>nd</sup> VDG next year should attend. We have a session for spouses on Saturday morning at 10 a.m. led by Lion Eileen Gaffigan.

We had a productive session looking at what we want to do about Camp Merrick. After much discussion and good input; we came up with a new plan. We decided not to go with Camp Merrick. We are going to do a one day retreat/workshop in early June between the 1<sup>st</sup> and 15<sup>th</sup>, to be held somewhere between Washington DC, Baltimore and Annapolis. We are looking a schools or churches for locations with low cost and we are looking at hotels in those areas. I guess they are not interested in their membership issues as I would like to put ideas in their newsletters and also to relate success stories that might inspire clubs to get new members.

# MD Extension Committee, PDG Harold Boccia (22A) - The following has occurred since our last meeting:

District A – The extension workshop has been moved from January to April 2-4. The location will be again in Parkville, Maryland. This will be open, not only in 22A, but in the multiple, as well. The outcome of this training is to launch a drive for a new club in the Kingsville Perry Hall area. The training will be conducted by Jim Canon from LCI. The Jarrettsville Lions Club has a lengthy article in the *Aegis* newspaper on the club.

District B – Last week PDG Paul Baker from Toronto conducted a workshop in District B for both Extension and Guiding Lions. Fourteen Lions attended. Potential clubs are still being worked on for Salisbury University and WOR–WIC College. Washington College in Chestertown is still in the planning and the formation has delayed until later in the fall of this year. First, clubs are notorious for not sharing information within the district. Second, we hoped that an activity might catch the eye of another club as being useful within their community. The result to date is a response from one club, Severn River, to add the additional service projects not listed and a comment to me from DG John that some clubs have commented that not all of their projects had been noted. Whether it is through competition, information or inspiration if clubs expand on the activities their members are doing within their communities, the members become more active. Active members stay in Lions and inspire others to become Lions.

I did an analysis of the drops through December. The breakdown for leaving Lions was: 15 moved, 9 family/work responsibilities, 6 deceased, 6 unhappy with club/district issues, 6 dropped by club - no activity, 5 health issues, 5 financial/job loss, 2 students in Campus club - left school, 2 dropped Lions.

Nothing changes. Tough financial times will cost us members and age takes its toll. Growing is adding more members than you lose.

Constitution and By-Laws Suggestions, PIP Clem Kusiak (22A) – Congratulations to DG John and Jeri Jo on a wonderful event. I want to compliment PDG Harold Boccia on his promotion of the publicity in the newspaper. Publicity to the public is very, very important. We

should have our events listed on the marquees of hotels and restaurants where we hold our events. Take copies of newspaper articles to events and give them out to everyone in attendance.

We had a session 3 years ago at the International Convention with Leos about the Lions Quest program. Young adults know they will be successful if the events were broken down into parts.

I have given my thoughts and ideas to the Council and they were discussed at a special Council meeting in January. In addition to having the necessary tools, I also discussed with the Council opportunities for a more functional Multiple District 22 Convention Committee and recommended the following:

- Budget shall reflect registered attendees planned to attend convention.
  - Purpose Allow Council to understand and interact with the MD22CC rationale in developing their budget.
- Final reports shall be uniform in reporting variances, including the final version.
  - o <u>Purpose</u> All financial reports, budgets, revisions and final report will be helpful for future budgets established and closed by the MD22CCT.
- Advance to the Convention Committee shall be based on previous year membership with full amount advanced to the committee at WISK meeting for the committee to begin operating.
  - o <u>Purpose</u> This will allow for up front planning by the committee.
- Vice Chair of MDCC prepare a budget for the 1st Vice District Governors to review and approve approximately 6 months prior to their year as District Governor.
  - O Purpose: This will allow for the MD22CC to report variances in a timely manner in addition to early planning, etc. by the Multiple District Convention committee. Also, allow for major changes as requested by the FVDGs while planning a major change in convention venue.
- MDCCT shall develop a 3 year "Trend Sheet" reflecting existing year actual previous budgets, actual and percent of change from each prior year. MD22CCT shall provide this to FVDGs at time of the committee budget 6 months prior to the FVDG's taking office.
  - <u>Purpose</u>: Changes in Convention Locations and or venues are most always difficult to understand with regards to final cost of participating in a new site.
     Trends will provide a less burdensome means of communicating to Council.
- MDCCC shall submit letter prior to December Council meeting requesting approval by Council for ticket sales, booth rentals, golf, etc. per C & BL.
  - o <u>Purpose</u> Early planning for the MD22Council is important to planning by the committee and District Governors.
- MDCC shall prepare "Committee Activity" schedule prior to the turnover meeting as a Committee tool for Council and the committee. MD22 CC shall review the schedule with Council during this meeting, update as necessary meeting Council and Committees objectives.
  - <u>Purpose</u> Council and Committee will now have an interactive method of understanding needs of both groups. This will also provide tracking method of viewing missed targets etc.

Research and Long Range Planning Suggestions, PIP Clem Kusiak (22A) – I recommend two additions to the Policies & Procedures Manual:

- The Multiple District 22 Constitution & By Laws Chair is responsible for updating the C&BL any all revisions voted on by the Delegates and forwarded within 30 days of the close of the Multiple Convention to the Council of Governors, Advisors, FVDGs and SVDGs and MD22 Web Master for inclusion in the MD22 Web Page.
- The Multiple District 22 Research and Long Range Planning Chair is responsible for updating changes to the R&LRP manual as approved by Council and forward within 30 days of the close of the Lions year to the Council of Governors, Advisors, FVDGs, SVDGs and MD22 Web Master for inclusion in the MD22 Web Page.

**DG Bill Bicknell (22B)** moved that the recommendations presented by PIP Clem be forwarded to the appropriate committees, specifically, the Constitution and By-Laws and Research and Long Range Planning Committees; second by DG Sandi Halterman (22C); motion carried.
